Keezlenutten Farm will be offering 4 different 1-week day camps this summer for children ages 8-18. They will be: June 17-21, July 8-12, July 15-19 and August 5-9. Campers need to arrive at Keezlenutten Farm by 8:00 am and be picked up by 4:30 pm. The cost of camp is \$375.00 per student. Each week will have a maximum of 12 students, availability on a first come, first served basis held by a \$50.00 deposit. We are also offering multiple Intermediate and Advanced camps for those children ages 8-18 that are jumping, and Half Day camps for children ages 6-10. If you, or someone you know, are interested in receiving more information about these camps, please contact me.

The schedule during the week will be as follows:

8:00 – 9:00      Bring in and feed horses  
9:00 – 11:00     Riding lesson (students will be broken up into groups based on their skill level)  
11:00 - 11:30    Untack and groom horses  
11:30 – 12:30    Lunch (pack your own)  
12:30 – 2:00     Learning project of the day or craft  
2:00 – 4:00      Second riding lesson  
4:00 - 4:30      Untack and turn out horses

**On Friday, everyone is invited to watch an exhibition starting at 2:30. All campers will participate.**

During their stay, students will review the following:

- Basic farrier work (our farrier will give a shoeing demonstration)
- Cleaning stalls (the campers' favorite part!!)
- Health and medical care
- Cleaning tack
- Conformation
- Costs of owning and caring for a horse
- Grooming
- Feeding

This will be a great experience for both the novice and experienced horse rider, giving them an opportunity not only to improve their riding skills, but also learn how to care for a horse.
